## LISTING AGREEMENT (10%)

It is hereby agreed between \_\_\_\_\_ (Seller) and Antique Boat Center Co.(Broker) that Broker is authorized to manage the sale of Seller's Boat \_\_\_\_\_; (described fully on backside) at a sale price of \$\_\_\_\_\_ or any less sum to which Seller may hereafter agree. It is understood that if Broker procures a purchaser Broker shall handle the transaction and shall receive as compensation ten percent (10%) of the sale price. Minimum commission is \$750. Further, if the Boat is sold or exchanged within one year after termination of this Agreement to any party to whom the Broker introduced, offered, or showed the Boat, Broker shall still be due a ten (10%) commission from the Seller.

In consideration of the commission paid, the Broker warrants to the Seller that he has brought the highest offer received. No Boat will be purchased by the Broker without disclosure.

When Seller receives payment in full for Boat (including trailer and other equipment, if applicable), Seller has forty-eight (48) hours to forward to Broker executed clear title and/or other proof of ownership.

It is understood between Broker and Seller that Seller shall be permitted to sell the Boat on his own, and should Seller so procure a buyer on his own, Broker shall not be entitled to any compensation for said sale or transfer. Seller must notify Broker of sale within 30 days.

If Boat is consigned to Broker's facilities, owner will maintain "port risk only" coverage on the boat and there will be a storage charge of \$2.00 per foot/per month for a 16' boat. Broker will maintain insurance for damage done to Boat due to Broker's negligence.

Broker agrees to:

1. Advertise the Boat as Broker deems appropriate.
2. Make proper arrangements to show the Boat to prospective buyers.
3. To handle the transaction for the Seller in professional manner.

Any dispute arising between the parties to this Listing Agreement shall be resolved by the courts of the State of Ohio, and Seller hereby consents to the subject matter and personal jurisdiction of the courts of Ohio.

Upon any breach of any covenant of this Listing Agreement by Seller, in addition to any other remedies or damages to which the Broker may be entitled, Broker shall also be entitled to recover from Seller the Broker's full and entire costs of enforcing this Listing Agreement, including court costs and reasonable attorney's fees.

This Listing Agreement shall remain in effect until either party give the other party thirty (30) day written notice of termination.
